Breeding Fee: The breeding fee for Anthem WSF, Westlife WSF, Maximotion WSF and Serpico WSF is \$800 for 2011. This fee includes one shipment. There is a \$250 non-refundable booking fee due and payable in order to book your Mare. This will be credited as part of the total Stallion fee. Photo copy of the Mare's Registration papers must accompany the booking fee.

Mare Approval: Sufficient pictures or video and pedigree must be sent to Wingspan Farms LLC in order to approve any Mare to be bred to the above Stallions prior to accepting a booking fee.

Additional Shipments and Collections: Additional AI shipments will be charged to the Mare owner at our cost for shipping and handling. Additional collection fees are \$250 per collection. Wingspan Farms LLC makes no warranty or guarantee that semen will be available for delivery within a certain time period. Mare owner understands that shipped semen is available on a first-come, first-served basis. While every effort will be made to ship semen when needed.

Pregnancy Verification: Wingspan Farms LLC recommends ultra-sounding all Mares between 16-20 days from breeding to verify viable conception. We do not recommend re-servicing any Mare showing heat that has been bred in the previous cycle until palpated and or ultra-sounded to confirm no viable conception has occurred.

Balance of Stallion Fee: To be paid in full upon confirmation of pregnancy no later than 45 days from the breeding date.

Breeding Certificates: Certificates are given to the Mare owner when the Mare foals.

Live Foal Guarantee: This guarantee means that a viable foal resulting from this breeding, will stand and nurse. If not, the Mare may be re-bred within one year from this contract with no additional breeding fee. However, additional charges for shipping, handling and collection costs will be applicable. If for any reason, the Mare booked to the Stallion in the breeding contract suffers illness, injury, or death which renders her unfit for breeding, the Mare owner may substitute another Mare to the above named Stallion when agreed upon by both Mare owner and Stallion owner. A letter from the Mare owner's Veterinarian must be furnished as proof of breeding unsoundness, as well as a letter of veterinary certification of foal death if the Mare has successfully conceived and delivered a foal that was unable to stand and nurse.

Non-Transfer Statement: This contract shall not be assigned or transferred by you and in the event that the Mare is sold, any unpaid fees are immediately due and payable, with no refund due from the Stallion owner under any circumstances.

Breeding Shed dates: The breeding shed opens February 15th 2011 and closes June 30th 2011. This contract is executed in duplicate and the same shall be binding upon both parties when accepted by you, the Mare owner(s), and signed by both the Mare and Stallion owner(s).
